The following Maps 101, 106, 108, 109 & 111 <u>are not acceptable</u> as this marginalizes the residents of Newbury Park who will be most affected by development of this parcel.

Any map which removes the Borchard Parcel from Newbury Park south of the 101 is unacceptable.

- -The Borchard Parcel & NP south of the 101 are in the same "community of interest" & the voting rights act requires that communities of interest remain together.
- -Splitting out the Borchard Parcel disenfranchises the residents of NP who will be most affected by development of that property. The voting rights act seeks to prevent this.
- -After looking at all of the maps I support map 104. It seems to be the fairest.
